2024 DINGHY AGREEMENT

Portsmouth Yacht Club ("PYC") and the undersigned ("Owner") agree as follows:

1. PYC reserves an area of the PYC docks for storage of dinghies being used during the current boating season.

4.	In exchange for prepayment of a dinghy fee set annually by the PYC Board of Directors,		
	Owner shall be permitted to keep one dinghy in the PYC areas reserved for dinghies from the		
	date of Docks In until one week before the date of Docks Out.		
5.	. Dinghy space is available to members who h	nave paid the dinghy	fee on a first come, first
	served basis. Other than dinghy pullout spaces under the pier, no spots are reserved for a		
	particular owner's dinghy. Those members who have been offered a pullout spot and have		
	paid the surcharge may have exclusive use of the pullout locations.		
6.	Owner shall not be entitled to occupy a space in the area reserved for dinghies until Owner		
	has paid the dinghy fee and provided PYC with proof of liability insurance covering the dinghy		
	in the minimum amount of \$300,000.		
	. Once registration is complete, the owner will	receive a sticker, fro	m the RC showing the
	dinghy is registered for the season. The sticker shall be affixed to the transom of the dinghy		
	visible from the dock.		
8.	. All hardware for docking dinghies under the	pier may not be move	ed without the permission of
	the Rear Commodore		
	. Owner is responsible for keeping the dinghy		•
	the risk of any damage caused to or by the dinghy while using PYC facilities, including		
	damage caused by non-members and/or contractors on PYC property at the invitation of		
	Owner.		
	PYC shall at all times retain ownership of the		
	Dinghy Agreement at any time if the Board of Directors determines that it is in the best		
	interest of PYC to do so.		
	Owner's rights under this Dinghy Agreement may not be assigned. Transient boaters using PYC moorings may use the dinghy dock for the period of their
